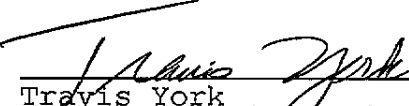

ARTICLES OF INCORPORATION

OF

Flooresource, Inc.

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be Flooresource, Inc. The principal place of business of this corporation shall be: 4083 Sawyer Court, Sarasota, FL 34233.

ARTICLE II - PURPOSE(S)

The general purpose for which this corporation is organized shall be the transacting of any or all lawful business for which corporations may be incorporated under the provisions of Chapter 607, Florida Statutes.
