The undersigned, acting as incorporator of a Florida corporation for purposes of forming a corporation under Chapter 607 of the Florida Business for Profit Corporation Act, hereby adopts the following Articles of incorporation:

ARTICLE I
NAME

The name of the Corporation is DeTore, Inc. (the "Corporation").

ARTICLE II

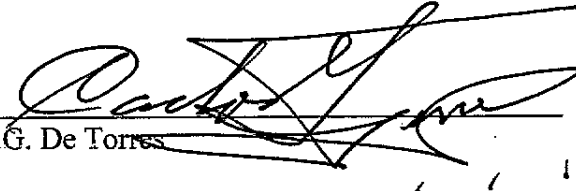
