

ARTICLES OF INCORPORATION OF BUNNY'S WEST INDIAN AMERICAN FOODS INC.

The undersigned subscriber to the articles of incorporation, natural person competent to contract, hereby forms a corporation under the state Florida.

ARTICLE I NAME

The name of the corporation is BUNNY'S WEST INDIAN AMERICAN FOODS INC.

ARTICLE II DURATION AND BEGINNING OF CORPORATION EXISTENCE
