ARTICLE 1. - NAME

The name of the corporation is R.E. JOHNSON ENTERPRISES, INC.

ARTICLE 2. - PRINCIPAL OFFICE

The principal office of the corporation shall initially be at 5113 Combee Lane, Sarasota, FL 34241. The corporation may change its principal office from time to time as permitted by law.

ARTICLE 3. - MAILING ADDRESS

The initial mailing address of the corporation shall be 5113 Combee Lane, Sarasota, FL 34241. The corporation may change its mailing address from time to time as permitted by law.

ARTICLE 4. - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.




