ARTICLES OF INCORPORATION OF

EVERYTHINGKID.COM, INC.,

A Florida Corporation

The undersigned incorporator, SHERI L. RICHARDSON, a natural person competent to contract, and with the consent of the owners, officers, and directors of the corporation created hereby, present theses Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME

The name of this corporation is EverythingKid.com, Inc., a Florida corporation.

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office of the corporation is 1306 Abbey Cresent Lane, Clearwater, Florida 33759.

ARTICLE III - PURPOSE
