ARTICLE I - CORPORATE NAME

In the absence of fraud in the transaction, the judgment of the Board of Directors as to the value of any such consideration shall be conclusive.

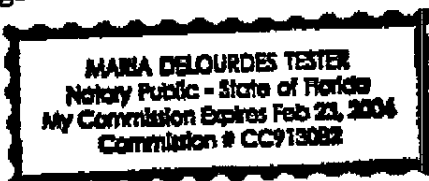
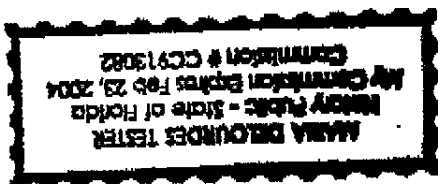
