The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

FIRST: The name of the corporation is Kendall Nuclear Medicine, Inc. The address of the principal office of this corporation shall be 9000 SW 87th Court, #111, Miami, Florida 33176 and the mailing address of the corporation shall be the same.

SECOND: The period of its duration is perpetual.

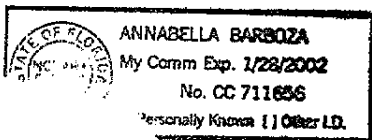

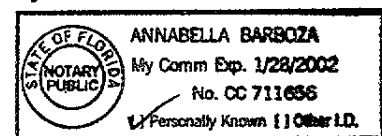
