### ARTICLES OF INCORPORATION

#### Gordon H. Weekes, Jr., P.A.

The undersigned, desiring to form a professional corporation in accordance with Florida Statute for the practice of law, do hereby adopt the following Articles of incorporation.

ARTICLE I

The name of the corporation shall be as follows: Gordon H. Weekes, Jr., P.A.

#### ARTICLE II PURPOSE

Each stockholder in the corporation, and each attorney employed by the corporation, shall practice law subject to the authority and power of the Supreme Court of the State of Florida to regulate such practice, and each such person shall at all times remain subject to reprimand or discipline for his conduct as an attorney.
