

OF

KNOW ALL MEN BY THESE PRESENTS, That the undersigned subscribers do hereby associate themselves together for the purpose of becoming a corporation under the laws of the state of Florida, by and under the provisions of the statutes of the state of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE II.


- The general nature of the business, or businesses, to be transacted by the corporation are:

 - (D) To make advances and loans for money and credit and to receive, accept, hold, collect and pay out deposits of money; to issue, receive, accept, hold, collect, assign and transfer debts, contracts, covenants and specialties; to receive and accept mortgages on real estate and of interest in land and collateral and other forms of security for money advanced and loaned by or due or owing to said corporation; to borrow money and secure the same by the issue of bonds, notes mortgages, and all other forms of security; to make, enter into, purchase, transfer and assign any and all kinds of contracts, agreement, bonds, notes or obligations; to make, enter into and perform contracts of any kind with any firm, person, association or corporation.


