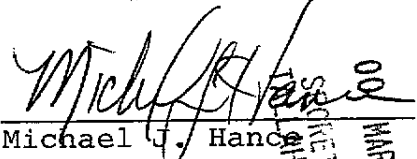

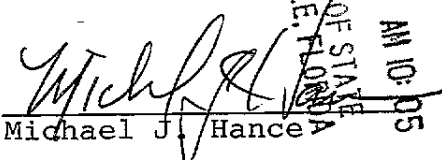
ARTICLE VIII - AMENDMENT

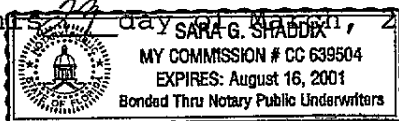

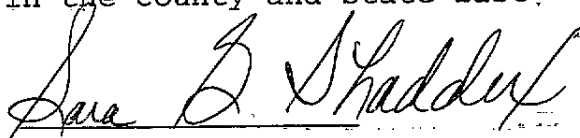
