

The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name for the corporation (hereinafter call the "Corporation") is:

Alien Safety Technologies, Inc.

SECOND: The duration of the Corporation shall be perpetual.

THIRD: The principal address of the Corporation shall be 1451 Azalea Avenue Casselberry, Florida 32707 and the mailing address shall be the same.

FOURTH: The number of shares which the Corporation is authorized to issue is One Hundred (100), and are the same class and are to be Common shares.


