ARTICLES OF INCORPORATION

OF

JUMP 4 JOY, INC.

ARTICLE I

The name of this corporation is: Jump 4 Joy, Inc.

ARTICLE II

The term of existence of the corporation is perpetual.

ARTICLE III

The purpose of this corporation is to operate a children's entertainment service, and any and all other lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of \$1.00 par value common stock.

ARTICLE V - PRE EMPTIVE RIGHTS

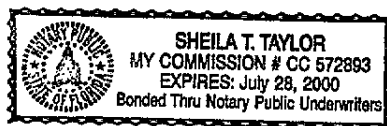
