

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under Chapter 621 of the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be: ADVANCED MEDICAL IMAGING OF PALM BEACH GARDENS, P.A.

The address of the principal office of this corporation shall be 2161 Palm Beach Lakes Blvd., Suite 304, West Palm Beach, Florida 33409, and the mailing address of the corporation shall be the same.

ARTICLE II - NATURE OF BUSINESS

This corporation may engage in every aspect of the business rendering the same professional services to the public that a Medical Practice, duly licensed under the laws of the State of Florida, is authorized to render. This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory, or nation.

ARTICLE III - CAPITAL STOCK




