It has been brought to my attention that your office has not received my 2002 annual corporate report. This is due to the fact that I never received the Uniform Business Report for 2002, nor have I received the 2003 Report forms. I not only I live alone, I work out of my home. I did receive a Notice of Administrative Dissolution or Revocation form and promptly forwarded said documents to my accountant.
