

The undersigned subscribers to these Articles of Incorporation, natural people competent to contract, hereby form a professional association under Chapter 621 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

The principal place of business of this corporation shall be, 5493 Carrollwood Meadows Dr., Tampa, FL 33625.

ARTICLE II. NATURE OF BUSINESS
