**ARTICLES OF INCORPORATION
OF

ARTICLE I – NAME

The name of this corporation is Builder2Builder.com Inc. (the “Company”).

ARTICLE II – PRINCIPAL OFFICE






ACCEPTANCE OF REGISTERED AGENT
