The undersigned does hereby make, subscribe, acknowledge and file this Certificate of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

ARTICLE I
NAME AND ADDRESS OF CORPORATION

The name of this Corporation shall be **S & K EQUITY INVESTMENTS INCORPORATED**, its address shall be 323 NW 36th Avenue, Deerfield Beach, Florida 33442.

ARTICLE II
GENERAL PURPOSE OF CORPORATION

To engage in all lawful businesses and ventures as allowed under the laws of the State of Florida.

ARTICLE III
CAPITAL STOCK

The maximum number of shares of stock this Corporation is authorized to have outstanding at any one time is One Hundred (100) shares of Common Stock having \$1.00 per share par value. RESTRICTION ON SALE OF STOCK

The Corporation shall have the power to include in its Bylaws any regulatory or restrictive provisions relating to the proposed sale, transfer or other disposition of any of its outstanding stock by any of its stockholders or in the event of the death of any of the Stockholders. 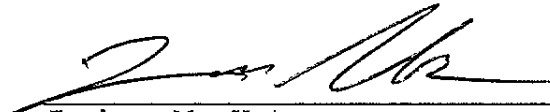

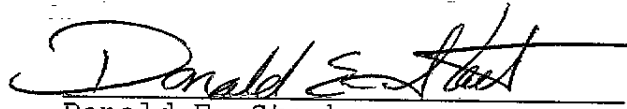

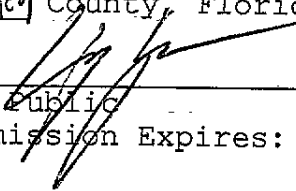
