CERTIFICATE OF INCORPORATION OF S & K EQUITY INVESTMENTS INCORPORATED

SCORING OF THE SCORIN The undersigned does hereby make, subscribe, acknowledge file this Certificate of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

ARTICLE I NAME AND ADDRESS OF CORPORATION

The name of this Corporation shall be S INCORPORATED, its address shall be 323 NW INVESTMENTS Avenue, Deerfield Beach, Florida 33442.

GENERAL PURPOSE OF CORPORATION

To engage in all lawful businesses and ventures as allowed under the laws of the State of Florida.

ARTICLE III CAPITAL STOCK

The maximum number of shares of stock this Corporation is authorized to have outstanding at any one time is One Hundred (100) shares of Common Stock having \$1.00 per share par value. 


