OF

ARTICLE I - NAME

The name of this corporation is K & N OF WESLEY
CHAPEL, INC.

ARTICLE II - DURATION

This corporation shall indemnify an officer or director, or any former officer or director, to the full extent permitted by law.


ARTICLE XI - AMENDMENT
