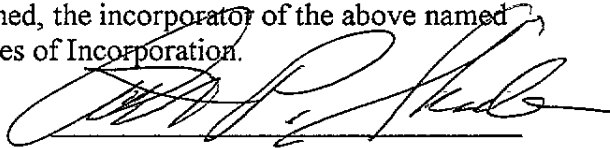
- First: The name of the corporation is Oyster Leisure, Inc.

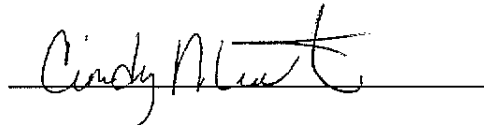
