**ARTICLES OF INCORPORATION**

**ARTICLE I. NAME.**

The name of this corporation is: **FLORIDA FOLIAGE, INC.**

**ARTICLE II. NATURE OF BUSINESS.**

The nature of business to be transacted by the corporation shall be:

A. To raise, propagate, develop, buy, sell, export and import, and generally deal in trees, shrubbery, plants, flowers, vines, and all other things raised and produced in a nursery; to acquire the necessary real estate, farms, or plants properly to carry out the above objects, and incidentally to engage in general farming to provide for the proper rotation of crops and the maintenance of the ground in a fertile condition.

B. To engage in any activity or business permitted under the laws of the United States or of the State of Florida.

**ARTICLE III. CAPITAL STOCK.**

This corporation shall have one (1) class of common stock having a par value of One Dollar (\$1.00) per share and the same shall be fully paid and nonassessable. The maximum number of shares of said stock this Corporation is authorized to have outstanding at any one time is Seven Thousand (7,000) shares.

**ARTICLE IV. INITIAL CAPITAL.**

The amount of capital with which this corporation shall begin business is Five Hundred (\$500.00) Dollars.

**ARTICLE V. TERM OF EXISTENCE.**

This Corporation is to have perpetual existence.

**ARTICLE VI. ADDRESS.**

The initial street address of the principal office of this Corporation in the State of Florida is:

The Board of Directors may from time to time move the principal office to any other address  
in the State of Florida.

**ARTICLE VII. DIRECTORS.**

This Corporation shall initially have one (1) Director. The number of Directors may be

never be less than one (1).



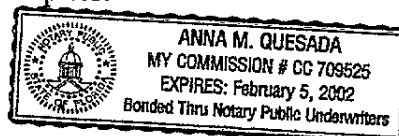
