



The undersigned, being of legal age and a natural person, does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation for profit under the laws of the State of Florida.

**ARTICLE I**

**NAME**

The name of the corporation is **ON TOP AGAIN, INC.** (hereinafter referred to as the "Corporation"). The principal office and mailing address of the Corporation is 199 E. Boca Raton Road #4-D, Boca Raton, Florida 33432.

**ARTICLE II**

**PURPOSE**

The Corporation is organized for the purpose of transacting any or all lawful business for corporations organized under the General Corporation Act of the State of Florida.

**ARTICLE III**

**TERM**

The term for which the Corporation shall exist shall be perpetual and it will commence upon the filing of these Articles of Incorporation with the Secretary of State of Florida.

**ARTICLE IV**  
**CAPITAL STOCK**

The aggregate number of shares which the Corporation shall have the authority to issue is 500 shares of Common Stock, par value \$1.00 per share.

**ARTICLE V**  
**INITIAL REGISTERED OFFICE AND AGENT**

The street address of the initial registered office and registered agent of the Corporation in this state is 199 E. Boca Raton Road #4-D, Boca Raton, Florida 33432, and the name of the initial registered agent of the Corporation at that address is Donna Kephart.
