

ARTICLES OF INCORPORATION

V.J. DEMAYO, INC.

ARTICLE 1

NAME

The name of this corporation is V. J. DEMAYO, INC.

ARTICLE II

DURATION

This corporation shall exist perpetually.

ARTICLE III

PURPOSE
