ARTICLES OF INCORPORATION 00 MAR 31 AM 9: 39 FOR DIGITOM GRAPHIC COMMUNICATIONS, INC. SECRETARY OF STATE TALLAHASSEE. FLORIDA

ARTICLE I - NAME

The name of this corporation shall be Digitom Graphic Communications, Inc.

ARTICLE II - DURATION

The duration of the corporation shall be perpetual.

ARTICLE III - PURPOSE

The corporation is organized for the purpose of transacting any and all lawful business under Chapter 607, <u>Florida Statutes</u>, as amended from time to time.

ARTICLE IV - AUTHORIZED STOCK

The corporation is authorized to issue Five Thousand (5000) shares of No Par Value common stock.

ARTICLE V - INITIAL REGISTERED AGENT

All rights conferred upon the shareholder of the corporation are granted subject to this reservation.
