### ARTICLES OF INCORPORATION OF DEKALB COUNTY STONE COMPANY, INC.

#### ARTICLE I. NAME

The name of this corporation shall be DeKalb County Company, Inc.

#### ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles Of Incorporation by the Florida Department of State, Division of Corporations. This corporation's duration shall be perpetual.

#### ARTICLE III. PURPOSE

This corporation is being organized for the purpose of engaging in the transaction of any and all business activities permitted under the laws of  $\underline{Fl}$ orida and the United States Of America.

#### ARTICLE IV. CAPITAL STOCK
