

ARTICLES OF INCORPORATION

LEAPFROG China, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act adopts the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation ("Corporation") shall be Leapfrog China, Inc.

ARTICLE II

Existence

The existence of the Corporation shall begin on April 1, 2000 and shall continue in perpetuity.

ARTICLE III

Principal Office

ARTICLE IV

Shares

The Maximum number of shares this Corporation is authorized to issue is 5,000,000; all shall be common shares.
