#### ARTICLES OF INCORPORATION

OF

#### NEW BEGINNINGS SERVICE, INC.

The undersigned incorporator of these Articles of Incorporation, natural person competent to contract, hereby form a corporation under the laws of the State of Florida.

## ARTICLE I. NAME

The name of this corporation is NEW BEGINNINGS SERVICE, INC.

## ARTICLE II. PURPOSE

This corporation is organized for the purpose of educating and training young people to possess skills of all building phases, locating and evaluating property, and all building maintenance, and transacting any or all lawful business in the State of Florida Statutes Chapter 607.

## ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock this corporation is authorized to have outstanding at any one time is 20 shares of common stock having a nominal or par value of \$1.00 per share.
