The Board of Directors may from time to time move the principal office to any other address in Florida.

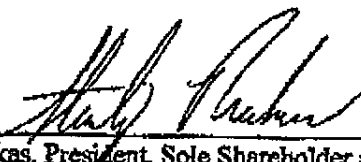
