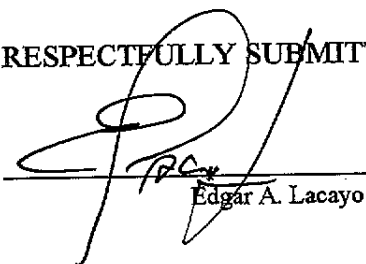

**ARTICLE I    NAME**

The name of the corporation shall be **AUTO DIMENSIONS, INC.**

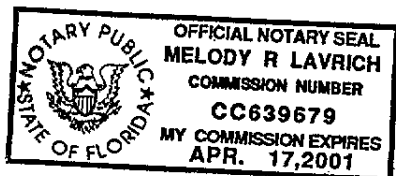
