
To whom it may concern:

On July 9, 2001 I received the 2001 Uniform Business Report. I was in the process of filing on-line when I noticed that the fee was \$550.00. At this time I reviewed the packet closer and noticed that I was filing a late return. I was aware that the fee would be in the \$100 - \$200 range, that is why it caught my attention. I was under the impression that the registered agent, who prepared our corporate papers would notify us and/or file for us and bill us. I contacted the agent only to get this response "when we created your corporation we were only obligated to you for 90 days, after that you are on your own". I expressed my concern how they do not notify anyone and/or at least let the proper parties be aware that the agent needs to be changed. Bottom line they did not notify us, so the agent was never changed and therefore the first report I see is this one, and I was totally unaware when the filing had to take place as I felt or believed that it was being taken care of by this firm. The final answer from the agent was that they would prepare a document requesting an exception or avoidance of penalty, cost \$250 with no guarantee whether it would be accepted or not, plus the fee of \$150 of course. We are a very small independent outfit wishing to operate legally. If I were to pay these people the little money we have in our checking account would be gone. I really think these people do this on purpose to later gain from it.

After my conversation with them, I decided to call your office and a very helpful individual told me not to file on-line, to go ahead and send in the \$150 with a letter explaining the circumstances and see if it would be accepted. This is what I am doing, hoping that someone can help us out. You will notice that I have changed the registered agent so that this does not occur once again, as I will receive all correspondence related to the corporation/filings etc. I have also marked the May 1st filing date on my calendar as a reminder to file before this date.

Your help in this matter would be greatly appreciated,
