The undersigned subscriber to these Articles of Incorporation, natural people, competent to contract, hereby make these Articles in order to form a corporation under the laws of the State of Florida.

ARTICLE I

The name of the Corporation shall be SERVELLO & SON PEST MANAGEMENT, INC.

ARTICLE II

ADDRESS


