THE UNDERSIGNED sole incorporator, being a natural person competent to contract and desiring to form a close corporation under the laws of the State of Florida, herewith submits the following information:

1.

The name of the Corporation is OFF THE TOP, INC.

2.

The Corporation shall have perpetual duration.

3.

The Corporation is a corporation for profit and is organized for the purpose of engaging in any lawful business for profit, and shall have the power to do whatever is necessary, conducive, or useful in carrying out the purpose of conducting business for profit, including the ownership and operation of real property and the improvement and development of real property.

4.

The aggregate number of shares which the corporation shall have authority to issue is 100 shares of common stock, all without par value and of one class.

5.

The Corporation shall not commence business until it has received not less than \$1,000.00 in capital.
