The undersigned hereby execute(s) and acknowledges the Incorporation in order to organize and incorporate a business for profit.

ARTICLE I - NAME

The name of the corporation is Edgard M. Cespedes M.D., P.A. with its principal place of business located at 11860 S.W. 49th Street, Miami, Fl 33175.

ARTICLE II- PURPOSE

The purpose of this corporation is to engage in any or all lawful business activity for which a corporation is permitted under the laws of the United States of America and of the State of Florida.



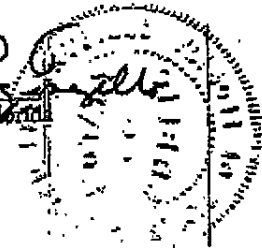
