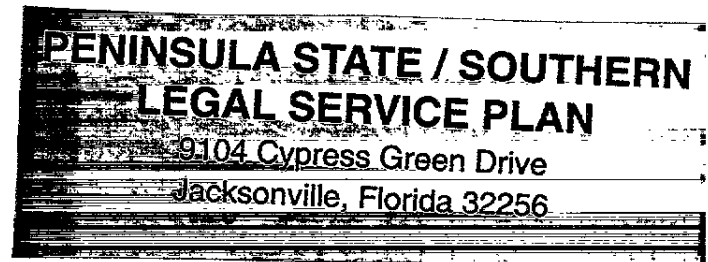

ARTICLE I

The name of this corporation is, U.S. Legal Services, Inc.

ARTICLE II

This Corporation shall have perpetual existence, unless sooner dissolved according to law.
