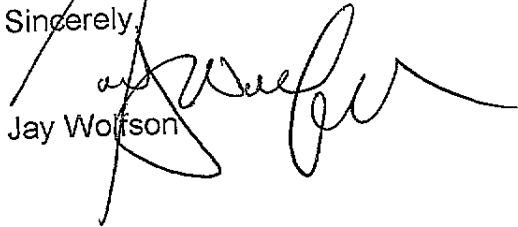
We are filing to incorporate a new Florida Professional Corporation, to be called Andrea Farrier, D.O., P.A.

**Articles of Incorporation
for
Andrea Farrier, D.O., P.A.
A Professional Corporation**

Recitals

The undersigned, who is duly licensed to practice the profession of medicine in the State of Florida, desires to form a professional corporation pursuant to Chapter 621 Florida Statutes for the purpose of rendering medical and health care and related services, and adopt the following articles of incorporation for such corporation:

Article One. Name

The name of the corporation is Andrea Farrier, D.O., PA

Article Two. Corporate Purpose

The purposes for which the corporation is formed are as follows:

- (a) To engage in the general practice of medicine as a medical corporation and to own and operate a medical clinic for the purposes of providing medical care and treatment.
- (b) To promote medical, surgical, and scientific research and knowledge; to furnish related laboratory and clinical services; to invest its funds in real estate, mortgages, stocks, bonds, or any other type of investment and to own real and personal property, to enter into contracts, and to engage in any lawful business necessary for the rendering of such professional services.
- (c) To do everything necessary, proper, or convenient for the accomplishment of any of the purposes herein set forth, and to do every other act and thing incidental thereto that is not forbidden by the laws of the State of Florida or by the provisions of these articles of incorporation.

The professional purposes of this corporation shall be carried out only through officers, employees, and agents who are duly licensed or otherwise legally qualified in the State of Florida to render professional medical services.

Article Three. Duration

The duration of the corporation shall be perpetual from 22 March 2000.

Article Four. Principal Office

The office of the corporation is to be located at 2322 Southern Lites Ave., Lutz, Fl. 33549, Hillsborough County, Florida.

Article Five. Shareholders

The names, residence addresses, offices, and license or certificate numbers of all individuals who are to be the original shareholders of the corporation are:

Article Five: Restrictions on Issuance of Stock

No capital stock of the corporation shall be issued to anyone other than an individual who is duly licensed or otherwise legally authorized to render the professional services for which the corporation was incorporated.

Article Six: Shareholder-Managed Corporation

The corporation shall have no board of directors. All of the powers of the corporation shall be exercised by, and the business and affairs of the corporation shall be managed under the direction of, the stockholders]. The name, address and title of the person appointed to act as the initial officer until the first annual meeting or until their successors are duly chosen and qualified is:

Article Seven. Certification of Authorization To Practice

Attached hereto are certificates issued by the appropriate licensing authority certifying that each of the proposed shareholders, directors, and officers is authorized by law to practice medicine in the State of Florida, for which the corporation is being organized.

Article Eight. Capitalization

The aggregate number of shares which the corporation shall have authority to issue is 1,000 common shares, of one dollar (\$1.00) par value per share, all of which shares are to be of the same class.

Article Nine. Agent for Service of Process

Jay Wolfson, Esq. is hereby designated as the agent of the corporation upon whom process against it may be served. Such agent may be served at 804 Eveningside Court, Tampa, Hillsborough County, Florida 33613.

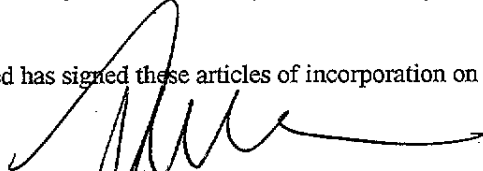

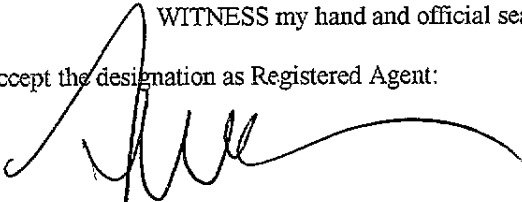

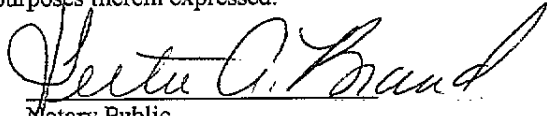
