ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
ANDREA FARRIER, D.O., P.A.

Pursuant to Section 607.1006 of the Florida Statutes, Andrea Farrier, D.O., P.A., a professional corporation organized and existing under and by virtue of the laws of the State of Florida (the "Corporation"), does hereby certify:

Name. The name of the Corporation is Andrea Farrier, D.O., P.A.

Amendments Adopted. The amendment adopted provides for the Corporation to change its name from Andrea Farrier, D.O., P.A. to Sanjeev Grover, M.D., P.A.

Text of Amendments. Article One is hereby amended by deleting such Article One and substituting the following new Article One which reads as follows:


"Article One. Name

The name of the Corporation is Sanjeev Grover, M.D., P.A."

Adoption of Amendments. The foregoing amendment was approved by unanimous written consent of the Board of Directors and shareholders of the Corporation pursuant to Sections 607.0704 and 607.0821, Florida Statutes, on June 17, 2005.
