**ARTICLES OF INCORPORATION  
OF

**ARTICLE I - NAME**

The name of this corporation is: European Motorworks And Repairs, Inc.

**ARTICLE II - DURATION**

This corporation shall exist perpetually, commencing on the date of filing of these Articles.

**ARTICLE III - PRINCIPAL PLACE OF BUSINESS**

The principal place of business for this corporation shall be 4053 Northeast 6th Avenue, Ft. Lauderdale, Florida 33334.

**ARTICLE IV - PURPOSE**

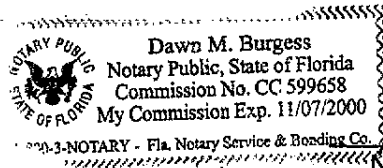
