ARTICLES OF INCORPORATION EXETEL, INC.

AM CALLED SO THE SO The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

<u> ARTICLE I - NAME OF CORPORATION</u>

The name of this corporation shall be Exetel, Inc.

<u> ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS</u>
