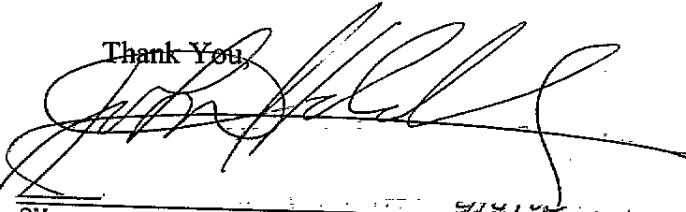

Article 1. The name of the corporation is: Cavallero Management, Inc.

Article 2. The principal place of business of this corporation shall be:

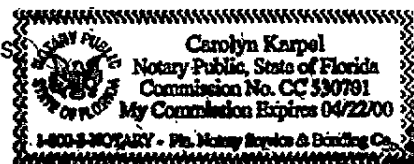
