ARTICLE I

The name of the corporation shall be David Hargreaves, Inc.

ARTICLE II

The purpose of the corporation is to buy, sell, and otherwise deal with realty and personality, both tangible and intangible, and to render services of a supervisory, personal, consulting, managerial, or other nature.

ARTICLE III

The corporation shall have perpetual existence, commencing on the date of filing of the Articles of Incorporation with the Department of State.

The aggregate number of authorized shares is 1000.


ARTICLE VIII
