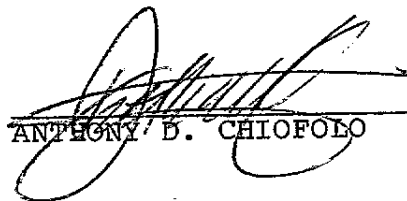
ARTICLE X - Effective Date

ARTICLE XI - Amendment

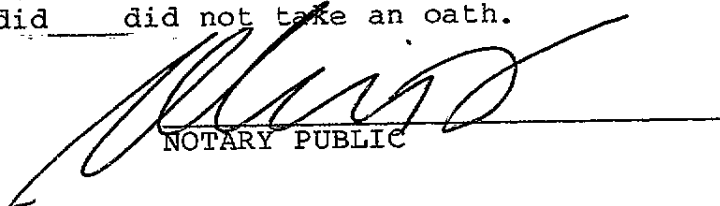

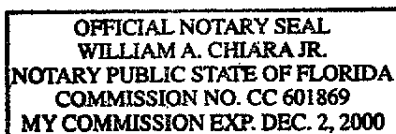

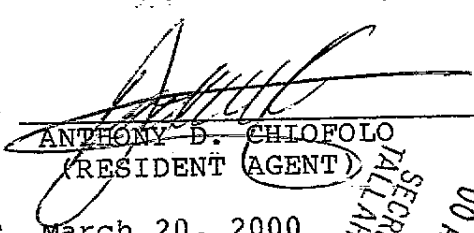
