We, the undersigned subscribers, hereby come before the state of Florida for the purpose of becoming a corporation. This corporation is organized by and under the provisions of For-Profit Corporation's statutes of the State of Florida.

ARTICLE I

GENERAL NATURE OF BUSINESS

This corporation may engage in all forms of businesses classified within a definition of the definition of the transportation industry. ARTICLE V

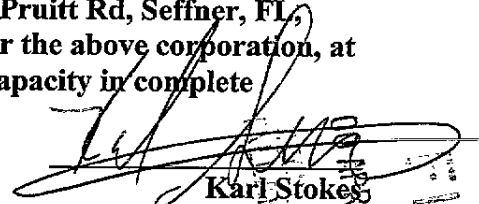
CORPORATE EXISTENCE
