ARTICLE I. NAME

The name of the corporation shall be

ARTICLE II. NATURE OF BUSINESS

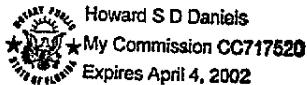


