ARTICLES OF INCORPORATION

of

CAFÉ TAORMINA, INC.

ARTICLE I

The name of this corporation shall be **CAFÉ TAORMINA, INC.**, and its principal place of business shall be 804 Southern Boulevard, West Palm Beach, Florida 33405.

ARTICLE II

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

The maximum number of shares of capital stock which the corporation is authorized to have at any time is ONE HUNDRED (100) shares of common stock at \$1.00 par value.
