ARTICLES OF INCORPORATION

OF

TODAY'S DEVELOPMENT CORP.

The undersigned subscribe to these Articles of Incorporation to form a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of this Corporation is TODAY'S DEVELOPMENT CORP. and its initial post office address and its principal office for the conduct of business is P.O. Box 21562, West Palm Beach, Florida 33416.

ARTICLE II

This Corporation shall exist perpetually.

ARTICLE III

This Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV

This Corporation is authorized to issue 500 shares of \$1.00 par value common stock.

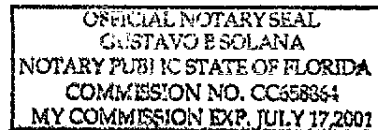
