The undersigned subscriber to these articles of incorporation, being duly licensed to sell and provide insurance products under the laws of the State of Florida, adopts these articles to form a corporation under the Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621, and other laws of the State of Florida.

ARTICLE I. NAME
