## ARTICLES OF INCORPORATION

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

### ARTICLE I

The name of the Corporation ("Corporation") is **The Perfect Tea Party, Inc.**

### ARTICLE II

The existence of the Corporation shall begin on date that these Articles of Incorporation are filed with the Florida Department of State. The Corporation shall have perpetual existence.

### ARTICLE III

The street address of the principal office of the Corporation is 1375 Burtwood Drive, Fort Myers, Florida 33901.

### ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is one hundred thousand (100,000) having a par value of ten dollars (\$10.00) per share, all of which shall be Common Shares.
