BY THESE ARTICLES OF INCORPORATION, the incorporator forms a corporation for profit under Florida law.

1. NAME. The name of the corporation is **JJJS, INC.**

2. TERM. This corporation shall exist perpetually, and shall begin operations in April, 2000.





