ARTICLES OF INCORPORATION OF BFM BACHMANN FINANCE MANAGEMENT, INC

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE 1 - NAME

The name of the Corporation is **BFM BACHMANN FINANCE MANAGEMENT, Inc.**, (hereinafter, "Corporation").

ARTICLE 2 – PURPOSE OF CORPORATION

The Corporation shall engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE 3 – PRINCIPAL OFFICE

ARTICLE 4 - INCORPORATOR

ARTICLE 7 - CORPORATE CAPITALIZATION

- 7.1 The maximum numbers of shares that this Corporation is authorized to have outstanding at any time is SEVENTHOUSANDFIVEHUNDRED (7.500) shares of common stock, each share having the par value of ONE DOLLAR (\$ 1.00).
