ARTICLES OF INCORPORATION

OF

COMENSAL, INC.

<u>ARTICLE I - NAME</u>

The name of the corporation is Comensal, Inc. (the "Corporation").

ARTICLE II - PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful business for corporations organized under the Florida Business Corporation Act of the State of Florida.
